The meeting start at 9H.

The President of the CU/FCI Mr. Frans Jansen, welcomed all and declared that he will be the official delegate of The Netherlands in the SM.UDC/FCI. As President of the UD/FCI he deplore the absences, with and without excuses, of the official delegates , in special the absence of Spain, organizer of the World Cup 2013 and Portugal organizer of the World Cup 2014 . A letter from M.F.Jansen as president of the UD/FCI will be send to the responsible of the Clube Portugues de Canicultura with the demand who is the official delegate and the letter that confirms the appointment and ask about their file of the organization for the organization of the world cup 2014. The candidature to organize the world cup 2014 was made by M. Celso Alves at the meeting in Lyss October 2011 , this candidature to organize was been confirmed by Md. Claudia Miranda at the meeting in October 2012 in Grande Synthe.

Mr. F. Jansen then gives the floor over to Mr. Roser .

2.

Mr. Roser declared that he is disappoint with the great number of absences, in special Spain , the organizer of the World Cup 2013 and Portugal organizer 2014. He ask the secretary M. Linclau to send a letter to M. Salazar with the demand what's already done for the file for the organization World Cup 2013. At the same time we send the organizer the specification for the organization of the Mondioring World Cup, and we ask him to read attentive the whole document and return a letter with the acceptation of the whole document to the coordinator and copy to the secretary and the president UD/FCI.

3.

M. Roser present the minutes of the last meeting 03 October Grande Synthe for approbation. The minutes are present in French, English and German, there are no remarks and the minutes are accepted .

4.

The modifications of the "Specification for the organization of the Mondioring World Cup", done by the secretary following the agreements in the meeting october2012 are integral accepted with addition of the modifications: Point 1.6 « ~~80€~~ 100€ » Point 5.5 « The President of the UD/FCI » Point 6.2 «The coordinator of the SM.UD/FCI » Point 8.2 « the dog for the country. » modifications accepted by the meeting 12 February 2013.

The document: " Specifications for the organization of the Mondioring World Cup", will be adapted by the secretary M. Linclau and send to the official members and to the organizer of the world cup 2013 M. Salazar. At this occasion the organizer will be informed who are the judges and decoy's that

are designed, at the same time, he will be asked, to send the official invitations and the utility information before the end of the month may 2013 with copy to the coordinator.

The document « Regulation for FCI – Mondioring judges » all ready accepted by the meeting of 02 marsh 2012 (version in English) and confirmed, will be presented by M. F.Jansen for approbation to the FCI General Committee at their next meeting.

7.

During this meeting M. F. Jansen will present and discuss about the total file Mondioring with the General Committee .

8.

The coordinator present the project « Course for apprentice judges Mondioring in countries where there NCO didn't accept the discipline » , the present delegates at the meeting ask the coordinator to continue the development of this project and make a point of the agenda for the next meeting of the SM .DU/FCI le 02 October 2013.

9.

By absence of the organizer 2013 there is no more information about the hand-out that M.Salazar present on the meeting of 03 October 2012.

10 .

The president of the CU/FCI M.F.Jansen present the document « Guidelines of the section Mondioring of the FCU Utility Dogs Commission for the pool of Mondioring Judges for the FCI World Cup » .This document will be translated (in English and German) by the president of the CU/FCI and send to all the members of the SM.DU/FCI. The coordinator will make a point on the agenda for acceptation on the next meeting of the SM.DU/FCI.

11.

The SM.DU/FCI will continue the investigation about the security of dogs and decoys. The coordinator will put this study on the agenda of the meeting on 02 October 2013.

The responsible of the international selection M.C. Munto and the supervisor M.I .Reimund will do the inspection of the protective suit of the decoys of the grand prix and the world Cup and also for the participants on the international selection. A report of the control will be established by the officials.

We remind the decision on the meeting in Fubine (Italy) 2008 :

The protective suit :

It must effectively protect the decoy, it must be flexible, allowed the decoy to make easy moves and to run with flexibility.

The suit may not be ridiculous, it may not have the sleeves too wide, and it may not be too hard that it prevent the bite of the dog .

It must allow to the dog a bite for at least 7 cm depth and at least, a thickness of the suit in the mouth of the dog of 3 à 5 cm.

It's an interdiction for the decoy to change his suit during a test in function for one or other dog.

12.

Holding of the judges during the world cup mondioring.

The coordinator present some ties, the delegates make their choice for the black tie with emblem color gold. The goal is to accentuate the ceremonial during the W.C.

13. Demand for a derogation exceptional of France, for the date of commitment for the French team on the world cup 2014, according with the condition that they will communicate on the expected day how many participants they will have, and communicate the coordinates of the dogs and the participants immediately after the national championship.

14.

Social test :

Agreed at the meeting 02 October 2011 :

During the veterinary control the practical social test of the GP and the WC has taken place in presence of the veterinary and a member judge of the section Mondioring; after verification of the identity the handler must present his dog without mussel and go straight and come back through a group of persons.

The work book will be controlled if the social test of his country is marked (Casu: in France BH international and others test in Belgium, Switzerland and others...)

It is a agreement that the countries accepted the social test of different countries if they have a official test. The above sentence means, that it is essential that every dog who is present at the W.C. and the Grand Prix, possess one or other social test, the SM.DU/FCI insist that the countries requires

that the dogs are in possession of the test before that they accepted them to participate in the trials .
The listing with the tests which are accepted will be refreshed before the W.C. 2013.

Add the U.S.A they have a test who's accepted at the meeting in October 2012, missing on the list of tests, the test of The Netherlands « Verkeersveilige hond » and the test of Sweden accepted by the Swedish federation.

A question from Belgium concerns the Norway Mondioring team, this country, where the NCO don't recognize the mondioring, they demand if they may create their own social test, the decision of the SM.DU/FCI is that in Norway the BH exist. The President of the UD/FCI M.F.Jansen will formulate a answer. The dog handlers from countries where the NCO don't adapt this discipline, also may do the social test in a country who has a recognized test .

The coordinator thanks the delegates for the work they have done and wish them a safe return home.
