The coordinator declare that he is proud of the judges for their worthy dress for a World Cup judge, a tie, with logo of the FCI, he thanks Mr. Frans Jansen that he make it possible that the expenses for the ties are taken by the FCI, the coordinator finished and thanks the Secretary of the SMUD/FCI Mr. Valeer Linclau for his personal great investment, his time and his knowledge for our discipline for all what is administration.

The coordinator made part of his deception concerning the answers of the general Comity on the different demands (CACIT, Pools of Judges and directives for Judges) that the SM-UDC-FCI made, we don't merit such a answer. Declaration subscribed by all the present delegates.

The document Pool « Directives of the FCI for judges Mondioring » all ready accepted in the meeting of 02 march 2012 (English version) and confirmed, are definitely accepted. The file has been proposed by M. F. Jansen for approbation at the General Comity of the FCI but was not retain. Stay under consideration.

The project « Course for postulants Judge Mondioring in the countries where their OCN don't adopt the discipline » The coordinator made the presentation of his file at the present delegates, they will be translate by par Md. Iris Remund and Mr. Bernard Roser in German. The team of Mr. Stefano Cetto will made the translation in English. The translation of the definitely file will be introduced for acceptation in the 15^e meeting of the SM-UDC-FCI the 01 October 2014 at Merano.

Presentation by Italy were the G.P. and the World Cup will take place under the aegis of ENCI, here represented by par Mr. Cetto et Mr. Oppizzi, Mr. Cetto present at all the members a document white some pictures of the place and the fields where the World Cup Mondioring 2014 will take place. The coordinator and the present delegates congratulate Italy for the work that they all ready did. Mr. Cetto declare that the web site will be create with all the information's concerning the World Cup, he will inform the SM-UDC-FCI as soon as possible to make a link with the web site of SM-UDC-FCI www.mondioring.org .

Sociability test. The SM-UDC-FCI reminds to the note of Mr. F. Jansen President of the Commission utility dogs concerning the sociability test, the principle of the obligation to be in possessing of the sociability test was accepted in the meeting of 02 10 2011. Starting by the World Cup 2014 and other International trials, no more derogation on this obligation will be tolerated. The organizer of the W.C. has to mention it on the documents of inscription and make the control on the preceding.

Debriefing by the coordinator and the delegates of the SM-UD-FCI and the team leaders.

Closing of registration of the teams 01 September

Closing of nominal registration by the O.C.N. 08 September.

Derogation exceptional of France, for the date of commitment for the French team on the world cup 2014, according with the condition that they will communicate on the expected day how many participants they will have, and communicate the coordinates of the dogs and the participants immediately after the national championship.

9.

Demand for a derogation from Switzerland. Mrs. Michelle Biedermann ask if she can compete with her dog in level 3 after her function as decoy in level 1 and 2 .

As in the past the participation as handler wasn't authorize for the judges or decoy's who have a function during the World Cup in all category. See the minutes of the meeting of the SM-UDC-FCI of 06032009 . Mr. Munto, responsible of the de la selection 2014, confirm that at the end of the international selection he asked at the decoy's who were selected , if they accept the function as decoy. This was confirmed by the 4 selected decoy's included Mrs. Biedermann. If the reserve decoy

hurts himself, it's the other decoy of level 1 or 2 who had to replace him. The answer is, as in the past, negative, Mrs. Biedermann accepted and give her worth to do the function as decoy.

10.

The Security of the dog and the decoy's. The protection suit of the decoys G.P. and W.C. and the participants of the international selection will be controlled by the responsible of the international selection Mr. V. Linclau the coordinator Mr. B. Roser and the supervisor Mrs. I.Remund. a rapport of the control will be established by the responsible .

We remind the decisions of the meeting in Fubine (Italy) 2008 :

The protective suit :

It must effectively protect the decoy, it must be flexible, allowed the decoy to make easy moves and to run with flexibility.

The suit may not be ridiculous, it may not have the sleeves too wide, and it may not be too hard that it prevent the bite of the dog .

It must allow to the dog a bite for at least 7 cm depth and at least, a thickness of the suit in the mouth of the dog of 3 à 5 cm.

It's an interdiction for the decoy to change his suit during a test in function for one or other dog.

11.

Worthy dress for judges during the World Cup 2014, a tie, for the ladies a scarf, the coordinator will contact the President of the UDC/FCI to obtain the refund of expenses by the UDC/FCI.

12.

The invoice of the web site 2013-2014 was 32,67€ was prepaid by the secretary Mr. V. Linclau. As agreed in the past it's the organizer of the next year who take it in charge , Mr. C. Oppizzi refund the invoice for Italy.

13.

Organization 2015, till now no demands.

14.

The letters of accreditation made by the OCN, once more we insist that the OCN of the countries who accepted this discipline address the letters of accreditation to the Coordinator with copy to the secretary of the SM-UDC-FCI. Only the countries who accepted the discipline and had designate a official delegate will have the right to participate at the meeting of the SMUDC/FCI and they have the right to vote.

15.

Demand of the delegate of Russia M. Andre Pobukovsky, to address a letter to the Russian kennel club concerning a eventually organization of the World Cup 2017 ,see the minutes of 02/10/2013.

We regret the absence of Mr. Pobukovsky. We like to have some information and specifications, but it is the OCN who must contact the SM-UDC-FCI and propose a organization eventual. We will send a mail to Mr. Pobukovsky to obtains more information.

16.

Eventually proposals for modification of the rule book Mondioring. See point 11 of the minutes of 02 October 2013 – 13^e meeting of the SM-UDC-FCI.

After the negative answer of the General Comity of the FCI about the files who were introduced (CACIT – Pool of judges – directives for judges) the opinion of the meeting is that it will be no save to introduce other documents for acceptation about Mondioring. The coordinator and the present delegates have the meaning that it will be better to wait at minimum 2 years before we introduce other demands for modifications or acceptations.

17.

The coordinator thanks the delegates to be present and for the work they made. The meeting is declared closed at 4.30 PM.
