Start the agenda with the approbation of the last minutes of the 14^e meeting SMUDC/FCI of 22 February 2014 in Vendenheim, the presentation of the minutes are in French and English, after reading there are no remarks and the minutes are accepted. The Secretary declares that he has no more a translator for the minutes in German language. Mrs. Iris Reimund from Switzerland agreed to make the translations of the minutes in the German Language for the future.

The letters of accreditation made by the OCN: a confirmation will be done by M. Alexandru Bondar at his Kennel club of Romania. M. Nuno Gil Ferreira will make a demand of confirmation for the future at his Kennel Club of Portugal.

Presentation of the conduct of the G.P. and World Cup by M. Stefano Cetto.

The project « Course for postulants Judge Mondioring in the countries where their OCN don't adopt the discipline » The file will be discussed again during the 16e meeting of the SMUDFCI February 2015.

6.

Presentation by M. Linclau of the International Selection for decoys. He also propose to customize the text signed by the responsible of the OCN concerning the insurance of the decoys for the dogs. The proposal is refused. The text will be discussed at the next meeting February 2015.

7.

Demonstration of the Mondioring program for the members of the General Comity FCI 01 and 02 November 2014 Amsterdam.

The President of the UCFCI M. F.Jansen declares that probably the demonstration will be cancelled. There should be a meeting with M. F.Jansen and the coordinator M. Roser with the General Comity

at Amsterdam. M. F. Jansen propose to present a video of the program. M. Cl. Munto propose to present a Press Kit and declares to take care for the preparation of the Press Kit.

8.

Organization 2015, till now no demands. The Coordinator ask at the present delegates if their country made a proposition ,there are no proposition for 2015 and then the coordinator declares to make a demand to the French Kennel Club the SCC if there is a possibility to organize the World Cup 2015 in France.

The amount of the invoice of the web site 2014-2015 is 36,30€ prepaid by the secretary M. V. Linclau. By agreement on the meeting in the past it's the organization of the next year who takes it in charge. The invoice will be transmit to the organization 2015 for recovery of the amount .

M. V. Linclau make the proposal - subject to the approval of the National Cynology Authorities – for the organization of the World Cup 2016 in Belgium. He presents a file to the delegates, already prepared by the candidate organization. The delegates agreed the proposal for the organization World Cup 2016 in Belgium – under condition of the approval by the national Cynology authorities – must be confirmed next meeting of the SMUDFCI February 2015.

5.55 PM – Briefing for the delegates of the countries who don't adopt the discipline and the team leaders.

The coordinator wish the judges and delegates a sportive World Cup and International trial, who will be a well merit publicity for this Mondale sport . The meeting is closed at 6.30 PM.
