The meeting start at 9AM.

The coordinator welcomed and thanks the present delegates.

Start the agenda with the approbation of the last minutes of the 15^e meeting SMUDC/FCI of 01 October 2014 Merano - Italy, the presentation of the minutes by the secretary are in French, English and German, after reading there are no remarks and the minutes are accepted.

The project « Course for postulants Judges Mondioring in the countries where their OCN don't adopt the discipline » The file will be treat again after the decision of the General Comity FCI following the demonstration on 19 marsh 2015 in Lobbes - Belgium.

The coordinator thanks the organizer of the World Cup 2014 Merano Italy M. Stefano Cetto and his wife , their team, for the perfect organization certainly with the short time they had to do the preparation, he also thanks all the competitors for their exemplary comporment during this World Cup .

The coordinator thanks the judges and the decoy's for their exemplary performance and that at all the levels . The international selection for decoy's happened without incidents under the responsibility of M. Valeer Linclau.

Reflection about the W.C.2014 : take note made more attention to see that the enclosure of the field is solid, in case of using barrier make attention that they are close down to the ground ;

During the search take care that the 2° decoy is in a room (closed) who is situated at minimum 5m from the field (if it is possible farther away) so that the dogs can't enter and that the dog can't see the decoy .

Presentation of the G.P. and World Cup 2015 by Mr. Bernard Roser from the club AC Vendenheim – G.P. and W.C. will take place at Vendenheim - France under the aegis of the SCC. Mr. Roser present at all the members a document with the schedule of the event. Starting by the World Cup 2014 and other international trials, no more derogation on this obligation will be tolerated . ** In the meeting of 28 February 2015 the SMUDFCI decide to make a derogation in the cahier des charges concerning the organization of the G.P. the specifications for the FCI Worldcup will be adapted : the actual text « before the W.C. » who means on Thursday on the field of the W.C. The text will be modified with : or on Friday of the W.C. on a other field if the organizer wants it and under condition agreement of the SMUDFCI who will examine if the organizer posses a large surface, to make 2 fields on the same site and away enough one to the other so that it will not obstruct/ disturb the trials.*

The Security of the dog and the decoy's. The protection suit of the decoys G.P. and W.C. and the participants of the international selection will be controlled by the responsible of the international selection Mr. Cl. Munto the coordinator Mr. B. Roser and the supervisor Mr. V. Linclau a rapport of the control will be established by the responsible.

We remind the decisions of the meeting in Fubine (Italy) 2008 :

The protective suit :

It must effectively protect the decoy, it must be flexible, allowed the decoy to make easy moves and to run with flexibility.

The suit may not be ridiculous, it may not have the sleeves too wide, and it may not be too hard that it prevent the bite of the dog .

It must allow to the dog a bite for at least 7 cm depth and at least, a thickness of the suit in the mouth of the dog of 3 à 5 cm.

It's an interdiction for the decoy to change his suit during a test in function for one or other dog.

10.

Worthy dress for judges during the World Cup 2015, a tie, for the ladies a scarf, the coordinator will contact the President of the UDC/FCI to obtain the refund of expenses by the UDC/FCI.

11.

The invoice of the web site 2014-2015 was 36,30€ was prepaid by the secretary M. V. Linclau. As agreed in the past it's the organizer of the next year who take it in charge, M. B. Roser refund the invoice for France, organizer 2015.

Organizer 2016, Belgium, the organizer 2016 M. Yves Carton will be invited by the organizer 2015 on Saturday 03 and Sunday 05 on the W.C. 2015.

The letters of accreditation made by the OCN, once more we insist that the OCN of the countries who accepted this discipline address the letters of accreditation to the Coordinator with copy to the secretary of the SM-UDC-FCI. Only the countries who accepted the discipline and had designate a official delegate will have the right to participate at the meeting of the SMUDC/FCI and they have the right to vote.

Schedule for the demonstration Mondioring to the General Comity FCI. We received confirmation by the President of the UCFCI M. F. Jansen for the demonstration on Thursday 19 March 2015. The place will be the field of the club in Lobbes at 6 km from the head-quarters of the FCI in Thuin. M. Yves Declercq (Executive Director of the FCI) will make a arrangement for the shuttle for the members of the General Comity for the demonstration Mondioring, previous arrival 14.30 AM, departure 16.30AM. This gives us 2 hours to welcome, demonstration and evaluation with the General Comity. M. F. Jansen Président de la UCFCI, M. Roser Coordinator, M. V. Linclau Secretary et M. Cl. Munto will be present to welcome the General Comity. Will be present for the demonstration M. J. Helsen, Belgium judge with his dog Malinois level 3 , M. V. Linclau, Belgium judge with his Bouvier level 2 . As decoy we obtains the cooperation with M. Jimmy Foster who will be present. We have at our disposal the installations of the club « Les amateurs sport canin Lobbes ». meet us at 11 PM on the place, the bar will be at our disposal for the welcomes drink. M. Munto prepared a document with the program Mondioring in en form of a flyer who will be transmit at each member of the General Comity.

Organizer 2017 : There was a proposition in the 13^e meeting of the SMUDFCI the 02/10/2013 by the delegate of Russia M. Andre Pobukovsky to send a letter to the kennelclub that concerns the

eventually organization of the W.C 2017. We told him that the country who proposed to organize or the designate organizer must send a letter to the SMUDFCI, after this no more news from Russia. M. A. Pobukovsky was excused for the 15^e meeting. Again we deplore the absence of M. Pobukovsky, not excused. To avoid problems we had in the past we propose to ask a organizer who can confirm. Portugal was candidate for 2015 and came back a little late on their candidature we ask the delegate for Portugal M. Nuno Gil Ferreira to propose to his National Kennel club the organization W.C. 2017. M. Nuno Gil Ferreira declare to take some information in his Kennel club and inform us later.

The secretary received on 24/02/2015 a question from a owner of a dog Mondioring from Greece intended to the SMUDFCI .

« Dear Mr Linclau,

I am writing on behalf of a friend whose English is not very good and he wants advice on a serious matter. He has a male malinois who is 5 years old and has already taken part in a number of Mondioring trials. The dog has developed a condition that requires that his testicles be removed. Can this dog continue to participate in competitions? Under what conditions? What kind of certification would it be required from the vet?"

The question : « A male malinois 5 years old , who already participate at several trials mondioring. The dog developed a disease where the veterinary was obliged to removed his testicles. Can this dog proceed with the participation to the trials ? What are the conditions ? What kind of certification will be necessary of the veterinary ?»

The rule book Mondioring mentioned in point 4: "*Following the rules of the FCI, male dogs which participate in Mondioring trials must have two testicles that appear normal and completely descended into the scrotum*"

The meeting ask that all attestation and correspondence from any person or from any country they are will be made at least in one of the FCI languages :English, French, Spanish, and German.
