Communication about the formation for judges Mondioring from the countries where they don't recognize the discipline by the president of the CUFCI:

If under the responsibility of a Kennel club FCI, a formation for Mondioring judges is organized it's because the Mondioring is not (yet) recognized in his the country of the candidate judge, the person who is formed obtain the title of judge and is submitted under the current rules of the county where he did the formation and under the responsibility of the Kennel club mentioned above.

The judge don't became judge of his own country and can make function as judge of his own country This judge is submitted at all the dispositions and current requirements of the FCI rules and the rules of the country where he had the formation and certification .

By this and after a period of 3 years, a qualified judge is submit under the rules FCI if a judge has his residence in a foreign country during 3 years this judge can no longer make function as judge of his original country.

Who means that after a period of 3 years his own country (normal residence) don't recognize at this moment the discipline the judge can no longer make function as Mondioring judge.

The Security of the dog and the decoy's. The protection suit of the decoys G.P. and W.C. and the participants of the international selection will be controlled by the responsible of the international selection Mr. B. Roser and the supervisor Mr. C. Oppizzi a rapport of the control will be established by the responsible.

We remind the decisions of the meeting in Fubine (Italy) 2008 :

***The protective suit :***

***It must effectively protect the decoy, it must be flexible, allowed the decoy to make easy moves and to run with flexibility.***

***The suit may not be ridiculous, it may not have the sleeves too wide, and it may not be too hard that it prevent the bite of the dog .***

***It must allow to the dog a bite for at least 7 cm depth and at least, a thickness of the suit in the mouth of the dog of 3 à 5 cm.***

***It's an interdiction for the decoy to change his suit during a test in function for one or other dog.***

Worthy dress for judges during the World Cup 2016, a tie, for the ladies a scarf, the coordinator will contact the President of the UDC/FCI to obtain the refund of expenses by the UDC/FCI.

Organizer 2017, The represent of a country who don't recognize the discipline Denmark M. Corneliussen announced at the precedent meeting to investigate if there was no possibility to organize the World Championship 2017. M. Corneliussen is absent, Ms. Emma Svensson contact him by phone and M. Corneliussen told her there is no possibility to organize in Denmark in 2017.

M. Stephan Hubert delegate for Switzerland declare that he will inform if there is a possibility in Switzerland to organize the World Championship 2017 ,he will give a answer at the end of April 2016.

The letters of accreditation made by the OCN, once more we insist that the OCN of the countries who accepted this discipline address the letters of accreditation to the Coordinator with copy to the secretary of the SM-UDC-FCI. Only the countries who accepted the discipline and had designate a official delegate will have the right to participate at the meeting of the SMUDC/FCI and they have the right to vote. M. Frans Jansen, in his function as President of the UCD/FCI, will address a official letter to all the countries who don't recognize the discipline till now .
