### Minutes of the 21<sup>e</sup> meeting SMUDC/FCI 04 October 2017 Gornitz - Spain

The meeting start at 5 PM.

The Coordinator welcomes and thanks the present delegates and declare that he want that his successor is able to speak English.

The coordinator ask the present delegates if there is someone who will take the function as coordinator in the UDC-FCI in his place, there are no volunteers, so he ask more support and respect from certain delegates, and let know that the delegates must communicate the decisions of the SMUDC-FCI by the minutes of the SMUDC-FCI in their own country, and see that the rule book of Mondioring is respected in their country. The coordinator deplore that at the same date of the W.C Mondioring - date fixed and foresee in the specifications for the organization of the W.C FCI point 1.1, the 1<sup>e</sup> WE complete of the month October – there are other disciplines like the WUSV who have organize this year their own W.C.on this date. The delegate from Sweden Md. Oscarson of the UDC-FCI was present during the G.P. the international selection and the W.C. FCI 2016 in Belgium. During the last meeting of the UDC-FCI she congratulates the coordinator for the discipline Mondioring and declare that she was enchanted by the social compoment of the dogs and the sportsmanship of the participants. The coordinator deplore that there are no more delegates of the UDC-FCI present during the W.C. Mondioring FCI, even that the coordinator invited them each year .

2.The coordinator give the floor to the secretary to continue the agenda.

We start the agenda with the approbation of the last minutes of the 20<sup>e</sup> meeting SMUDC/FCI of 18 February 2017 in Meñaka – Spain. The presentation of the minutes by the secretary are reading in English and French. There are no remarks, the minutes are accepted unanimously. The coordinator thanks the secretary for his work.

Mr. Pobukovsky delegate for Russia organizer of the international trial1&2 , international decoy selection and the World Championship FCI Mondioring 2018 take the floor and confirm that the whole organization will be following the specifications for the to organization of the W.C. and it will be organized in all security .He will establish a document with different possibility's to come to Moscow . He will also have a discussion with the Russian kennelclub about the problems with the Russian visa anyway every participants and all the members of the delegation will receive a invitation from the Russian Kennelclub, document who is necessary to obtain a visa. The countries must send all the data of their participants and their delegates to the Russian kennelclub so that they can do the necessary. During the 22<sup>o</sup> meeting of the SMUDC-FCI in the month of February 2018 we will discuss about all this. The coordinator and the delegates congratulate Russia and his delegate for all the work that they already done.

We receive a official letter of the Polish kennel club who confirms that they accept the organization of the world championship Mondioring, the international trial 1&2 and the international decoy selection 2019 following the specifications for the organization of the W.C. The place of the W.Ch. will be Racibórz. The delegate for Poland M. Marcim Gawron, excused and replaced, send allready some previous documentation with the location and possibility's. Md Pogorzelska who represent Poland ( replace M. Marcim Gawron ) in this meeting confirms the organization of the World Championship FCI Mondioring 2019 by Poland.

The letters of accreditation made by the OCN, ones more we insist that the OCN of the countries who accepted this discipline send the letters of accreditation to the Secretary of the SMUDCFI with copy to the Coordinator.

6.

Worthy dress for judges during the W.C. 2017 a tie, for the ladies a scarf.

7.

Presentation of the progress of the World championship and the international trial 1&2 Mondioring 2017 by M. Ricardo Salazar.

8.

Presentation of the progress of the international decoy selection 2017 by the responsible M. Stefan Huber. Twenty four participants coming out of eight different countries.

9.

Security of the decoys and dogs. Control of the protective suits, for the decoy at the W.C. and G.P. and the participants at the international decoy selection.

10.

The implementation of a commission Mondioring regardless of the UDC-FCI. M. F. Jansen President of the UDC-FCI confirms that the proposal is transmitted to the offices of the FCI for insertion on the agenda of the next meeting of the General Committee FCI .

11.

The coordinator remarks that regular he receive Video tapes of trials Mondioring on which he ascertain that some decoys don't follow the Mondioring rules for decoys. The coordinator insist just as mentioned in the rulebook that the judges are responsible for the work of the decoys and the progress of the trial by consequences they are responsible and must correct the non correct work of the decoys.
